If you are unable to vote in person, your Absentee Ballot Request Form must be received no on the CTUIR website later than **10-17-25**. Absentee voting request forms are available http://ww.ctuir.org.

Per Section 3.11 (B), "any written request for an absentee ballot must be signed by the voter requesting the ballot, and his/her signature must be verified by Election Commission. Requests

for absentee ballots that must be mailed must be received by the Election Commission no less than twenty (20) days before the [General or] Special Election, as defined in section 3.01 of this [Election] Code.'

Section 3.11, (F), Absentee ballot request forms shall be made available to be picked up or mailed, as requested to all Qualified Voters fifty (50) days prior to General Election. The Election Commission shall use the Tribal newspaper [CUJ] to provide information about absentee balloting and how to request absentee ballots to Tribal members."

Absentee Ballots are scheduled to be mailed on or before 10-10-25 by regular mail.

You may submit your absentee ballot in the Ballot Box at the Nixyáawii Governance Center drop

boxes. It must be received on day of election by 8:00 pm on Tuesday, November 4, 2025.

#### 2025 General Election Calendar

August 05	<b>General Election Notice-</b> <u>Deadline</u> 90 Days Prior to General Election – Announced continually on KCUW, Posters throughout community, in CUJ, on Tribal Website. ( <u>Nomination Petitions will also be available at this time</u> )
August 25	Nomination Petitions Due-4pm. Deadline 70 Days Prior to General Election
August 25	<b>Constitutional Amendments Due</b> – <u>Deadline</u> 70 Days Prior to General Election. The complete text of the proposed amendment must be delivered to the Election Commission.
September 2	<b>Withdrawal</b> - <u>Deadline</u> 8 Days after Petitions Due a candidate may withdrawal, must be in writing, signed by candidate and notarized then delivered to the Election Commission.
September 12	<b>Absentee Ballot Request Forms Available-</b> <u>Deadline</u> 50 Days Prior to General Election
October 14	Absentee Ballots Mailed- <u>Deadline</u> 21 Days Prior to General Election
October 20	<b>Absentee Ballots Request Forms DUE to Election Commission</b> - <u>Deadline</u> 15 Days Prior to General Election
October 31	<b>Poll Watcher Letters Due-</b> <u>Deadline</u> 3 Days Prior to General Election. Each Candidate is entitled to choose one person as a poll watcher. Notify the Election Commission in writing identifying their poll watcher.
November 4	General Election - Day 8:00am-8:00pm at Nixyaawii Government Center
November 5	Document to GC stating elected officials
December 3	Swearing In
December 3	Removal of Campaign Signs- <u>Deadline</u> 30 Days after General Election
